#### **Monthly Membership Program Terms and Conditions:**

\_\_\_\_\_ (Initials) All services offered to members are for the face and monthly members services are rotated each month. No single service will be repeated on consecutive months.

\_\_\_\_\_ (Initials) Your membership service is non-transferable and apply solely to the individual enrolled as a member in the program. Membership services may not be combined with any other promotional offer.

\_\_\_\_\_ (Initials) Unused services are not refundable or may not be applied to any subsequent month. All services purchased through a membership, must be started within 3 months from the date of purchase. All fees will be charged on the first of the month and no proration will be applied to shortened months. Fees and charges are nonrefundable.

\_\_\_\_\_ (Initials) Appointments are made on a first come, first served basis. You are responsible for scheduling your monthly services in advance to ensure you receive your preferred date, time and aesthetician. If you are unable to keep a scheduled appointment, you must cancel with in 24 hours prior to your appointment or that service will be forfeited.

\_\_\_\_\_ (Initials) A valid ID and credit card are required to enroll in the Monthly Membership program. You agree to provide us with updated information if your address or payment information should change. If we are unable to process the automatic monthly membership dues, the membership will be suspended pending payment in full. Any accumulated services will be forfeited if the membership is suspended due to nonpayment.

\_\_\_\_\_ (Initials) All services will automatically renew, and your credit card will be charged for the current rate of membership at the time of renewal.

\_\_\_\_\_ (Initials) Monthly membership dues do not include gratuities.
